

# **Draft recommendation of priority substances for inclusion in Annex 14 (list of substances subject to authorisation) of UK REACH 2025**

**October 2025**



# Introduction

1. Article 58(3) of UK REACH requires the Health and Safety Executive (in its role as the Agency for UK REACH) to recommend substances of very high concern (SVHCs) from the [UK REACH Candidate List](#) to be included on the [Authorisation List](#) (Annex 14).
2. HSE is required to submit its recommendation to the Appropriate Authorities after inviting comments from interested parties on the draft recommendation over a three-month period.
